### √ Mail Solicitations

Starting in Spring/Summer 2012, The Friends of Riverside Park Conservancy intends to provide 2 newsletters per year (Spring/Summer and Fall/Winter). Because Riverside Park is located in a distressed neighborhood, FORPC has applied for funding under the Community Development Block Grant (CDBG) program, in order to reconstruct the stairway - now deteriorated and unsafe - by which students of the adjacent Winthrop Elementary STEM School, as well as neighborhood residents and visitors, enter the park. Government grant funding aimed at connecting STEM schools with open space for field study, or at improving parks and recreational facilities for low- and moderate-income residents are anticipated to be sought out in the future.
